**PO for YP8024X, SHC1331C and FBF8025X approved.**

2. YP8024X – IO Vilton

On 22.12.2017 at about 4.49 pm, 1 lorry and 1 TMA truck were stationary on the lane 2 of 3-lanes road after completion of road work along West Coast Highway towards West Coast Road near LP 19/1F. Deceased who was in-between the lorry and TMA truck was climbing up onto the lorry before moving off when the TMA truck suddenly surged forward and sandwiched the deceased to the rear of the lorry. TMA truck was hit by its rear by accused lorry which resulted it to surge forward. The deceased was pronounced dead at the scene.

**SHC1331C – IO Dzul**

**FBF8025X – IO Dzul**

On 25.12.2017 at about 7.21 am, motorcycle was believed to have failing to conform to red light signal in his direction along Upper Changi Road East towards Bedok at the signalised junction of TPE(PIE), skidded before collided with 1 motor taxi whom was making a right turn from motorcycle's left to right. Motorcyclist was conveyed to CGH in conscious state but succumbed to his injuries and pronounced dead on 26.12.2017 in CGH.
