Dear Vivian,

From our cctv, it clearly showed that there are 2 arrows for turning left ahead. The space is wide enough for 2 vehicles (even heavy vehicles) to turn left abreast. Your insured's bus is seen proceeding towards the right arrow which implies that our driver can proceed towards the left arrow on his left.



Your insured's bus is already at the right turning lane which means that our taxi can proceed towards the left turning lane.



when our driver saw your insured's bus coming near, he stopped to avoid a collision and horned to alert your insured's driver but to no avail.



your insured's driver continued to come closer and encroached onto our driver's path thus causing the accident. Your insured's driver had failed to look out when turning turn.



Please note that there are 5 gantries ahead with 2 for existing. The accident would not have occurred if your insured's bus had proceeded towards the right gantry (meant for the vehicles coming from the right turning arrow). It is clear that your insured's driver had negligently encroached onto our driver's path and collided onto our stationary taxi.

Fyi, we have rejected your insured's claim in view of the above.
