May I seek your assistance to perform a detailed mechanical inspection of the vehicle below:

a) Case: IAFP-IB-20171220 Mechanical Inspection of vehicle, Motor Car; SGN6422U (TP/IP/65761/2017)

On 10 December 2017 at about 12.51 p.m., B1 (motor car; SGN6422U) was travelling along Woodlands Avenue 1 towards Woodlands Avenue 2, made a right turn on a green traffic light only into Woodlands Avenue 2. In the midst of making the right turn into Woodlands Avenue 2 towards SLE, B1 collided into A1 (deceased) who was pushing a stroller filled with groceries at the pedestrian crossing along Woodlands Avenue 2 from B1's left to right side. As the result of the collision, A1 was conveyed by ambulance to Khoo Teck Puat Hospital in an unconscious state as she sustained head injuries. She succumbed to her injuries and was pronounced dead by Dr Vyne Cabral Shakya Marrie at 4.07 p.m. on 10 December 2017.
