ACCIDENT INVOLVING SFW 1111P(OI) & SHC 8830H(TP) ON 31/01/2018

We refer to the above matter.

Liability is not in our insured's favour as he rear-ended third party.

We are negotiating settlement with third party repairer. However, for LOR & LOI, third party is unable to accept our offer at 4days and proposed for 5days (strictly for an amicable settlement). Based on taxi driver mileage log record, the taxi was laid up in the workshop for 8.5days. Third party repairer informed us that their taxi driver did not take down OI's vehicle number as he was in daze after the accident and he was sent to Changi Hospital. Therefore third party repairer was unable to retrieve OI's vehicle until they received PIR from traffic police on 06/02/2018.
