I HEARD A LOUD SOUND AT THE REAR OF MY VEHICLE. BEFORE I GET OUT FROM MY VEHICLE, I CHECKED ON MY PASSENGER. HE THEN CLAIMED THAT HE IS OKAY AND NOT INJURED.
