Brief Details.

On 5th February 2018 at about 1150hrs, I was travelling along Woodlands Road, heading towards Bukit Panjang direction. I was travelling along the left most lane at that time when I was approaching the merging lane. I checked my mirrors before entering the merging lane and there was one civilian vehicle (SJR1202P) behind me. Once I entered the merging lane, I checked the mirrors again and the civilian vehicle was no longer behind but beside me on my right. Just then, this civilian vehicle sped up and wanted to turn left but its left rear side collided with the rights side of my vehicle.

As a result, my vehicle has got no damage but for the civilian one, the left rear side was dented and has some scratches. We both exchanged particulars and parted our ways. I have one passenger on board, Zhang Yuan but he is not injured. None of us was injured from this accident. I am lodging this report under the instructions of my camp.
