We refer to the above matter.

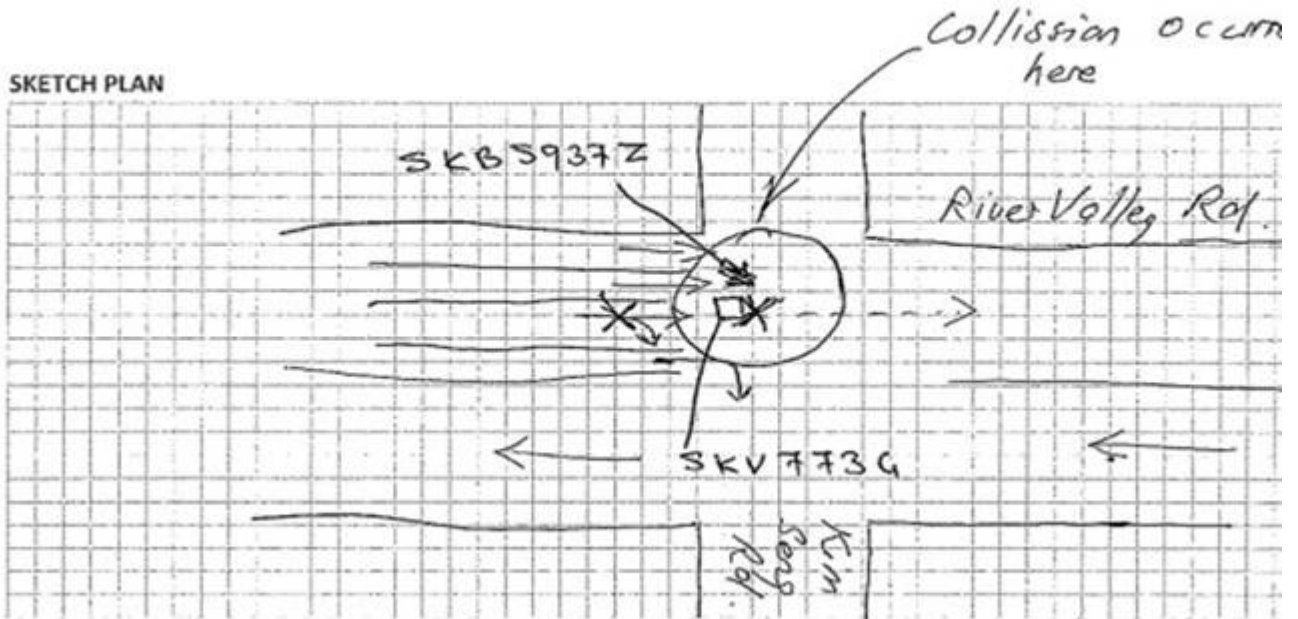

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was 1st car at junction of River Valley & Kim Seng junction (See diagram). I was on the 2nd lane from Centre divider which is a straight/right turn lane. When the light turned green I slowly moved on, so did the car on my left. As I moved on, I noticed the car (SKB5937Z) on my left (from the side) moving into the lane. Soon after I felt that car scrapping the left side of my car. I then honked my horn but the driver did not stop initially. I Continued honking & followed across the junction.
