

- c) Hirer who is holding a license less than a year, will be responsible for the full amount of the excess not exceed SGD\$6000 for own damaged and SGD\$6000 for third party claims upon reporting of the accident. Windscreen excess at SGD\$300.
- d) For travelling to Malaysia, The Hirer with license less than a year will be responsible for the full amount of the excess not exceed SGD\$12000 for own damaged and SGD\$12000 for third party claims upon reporting of the accident. g) In the event of an accident, the Sub - Contractor shall:

- i. Obtain vehicle registration numbers, photographs, names and addresses of the parties involved and of witness;
- ii. No admit fault or liability;
- iii. Not abandoning the Vehicle without adequate provision for safeguarding and securing the same; and
- iv. Notify the Company immediately

8. MALAYSIA USAGE

In the event of any breakdown of vehicle outside the Republic of Singapore, it is the Sub - Contractor's sole responsibility to tow back the vehicle to the Republic of Singapore at the Sub - Contractor's cost. All Malaysia usage is at Sub - Contractor's own risk.

9. LOSS AND DAMAGE

- a) Sub - Contractor hereby assumes and shall bear the entire risk of loss, theft, destruction and damage to the Vehicle from any and every cause or whatsoever, whether or not covered by insurance except for natural disaster involved. No loss or damage to the Vehicle or any part thereof shall impair any obligation of Sub - Contractor under this Contract which shall continue in full force and effect through the term of the Contract.
- b) In the event of loss or damage of any kind whatever to the Contract, The Sub - Contractor shall, at The Company's option:
 - i. Place the same in good repair, condition and working order; or
 - ii. Replace the same with like Vehicle in good repair, condition and working order; or
 - iii. Pay to The Company the replacement cost of the Vehicle.

10. SURRENDER

Upon the expiration or earlier termination of this Contract, Sub - Contractor shall inform the Company One Month in advance and return the Vehicle to The Company in good repair, condition and working order, ordinary wear and tear resulting from proper use thereof alone excepted, by delivery the Vehicle at Sub - Contractor's cost and expenses to such place as The Company shall specify within the city or country in which the same was delivered to Sub - Contractor.

11. FILING

Sub - Contractor, on request, agrees to execute any instrument necessary to the filing and recording of this Contract agreement or the Vehicle. Sub - Contractor further appoints The Company its true and lawful attorney to prepare, execute, and sign any and all security agreements, financing statements, or otherwise, in order to effectuate a lien on the property subject to this Contract, and to sign the name of Sub - Contractor with the same force and effect as if signed by Sub - Contractor, and to file such instruments at the proper location or locations.

12. LOCATION AND MAINTENANCE

The Company shall not be liable for loss of profit or other consequential damages resulting from the theft, destruction, or disrepair of the vehicle and there shall be no abatement of Contract payments on account of any such theft, destruction, or disrepair.

13. Vehicle Servicing

At no circumstances should the Sub - Contractor drives the car exceeding the mileage/date mentioned on the vehicle servicing label on the windscreen. The Sub - Contractor is liable to a penalty of SGD\$500 in the event.

14. TITLE & PERSONAL PROPERTY

The Vehicle is, and shall at all times remain, property of The Company, and The Sub - Contractor shall have no right, title, or interest except as expressly set forth in this Contract. The Vehicle is and shall at all times be and remain personal property although the vehicle or any part of it may now be or hereafter become in any manner affixed or attached to real property or any improvements. All additions or improvements to the vehicle or any kind or nature made by the Sub - Contractor shall become component parts of the vehicle and title shall immediately vest in the Company and be governed by the terms of this Contract.

15. INDEMNITY

The Sub - Contractor shall indemnify The Company against, and hold The Company harmless from, any and all claims, actions, suits, proceedings, costs, expenses, damages and liabilities, including reasonable attorney's fees and costs, arising out of, connected with, or resulting from The Sub - Contractor's use of the Vehicle, including without limitation the manufacture, selection, delivery, possession, use, or return of the vehicle.

16. DEFAULT

If The Sub - Contractor fails to fulfil provided on EVERY FRIDAY OF THE WEEK after the sum is due and payable, or if The Sub - Contractor fails to observe, keep or perform any other provision of this Contract required to be observed, kept or performed by The Sub - Contractor, The Company shall have the right to exercise any one or more of the following remedies:

- a) To declare the entire amount of rent hereunder immediately due and payable without notice or demand to Sub - Contractor.
- b) To sue for and recover all rents, balance tenure committed and other payments, then accrued or thereafter accruing.
- c) To take possession of the Vehicle, without demand and notice, wherever same may be located, without any court order or other process of law. The Sub - Contractor shall be liable to any and all damages occasioned by such taking of possession.
- d) To terminate this contract.
- e) To pursue any other remedy at law or in equity.
- f) Security deposit will be forfeited.
- g) Security deposit shall not be used to offset any payment owed to the company.

Notwithstanding any repossession or any other action which The Company may take, The Sub - Contractor shall be and remain liable for the full performance of all obligations on the part of the Sub - Contractor to be performed under this Contract. All the Company's remedies are cumulative, and may be exercised concurrently or separately.

Neither this Contract nor any interest therein is assignable or transferable by operation of law. If any proceeding under this Bankruptcy Act, as amended, is commenced by or against the Sub - Contractor, or if the Sub - Contractor is adjudged insolvent, or if Sub - Contractor makes any assignment for the benefit of his creditors, or if a writ of attachment or execution is levied on the Vehicle and is not re-contract or satisfied within ten (10) days thereafter, or if a receiver is appointed in any proceeding or action to which the Sub - Contractor is a party with authority to take possession or control of the Vehicle, The Company shall have and may exercise any one or more of the remedies set forth in Section 14 hereof; and this Contract shall, at the option of The Company, without notice, immediately terminate and shall not be treated as an asset of The Sub - Contractor after the exercise of said option.

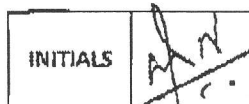

27. ENTIRE AGREEMENT


