2 **Case IAFP-IB-QX1026S Mechanical Inspection of vehicle, Motorcar, QX1026S TP/IP/02367/2018**

On 11/01/2018 at about 0900hrs, the driver of QX1026S was travelling on Choa Chu Kang Ave on the lane 2 of 2 lanes road, she saw a stationary taxi ahead and wanted to change lane however she was not able to do so. As such, She braked, however she was not able to stop in time and collided onto the rear of taxi. She claimed that the brake was faulty.
