Brief Details.

On 8 February 2018 at about 1150hrs, I was driving my taxi along Bishan Street 21 on Lane 1 approaching the Junction of Marymount Road. As the traffic light was red, I stopped my vehicle behind another vehicle, which I cannot remember the make and model. Soon after, the traffic light turned green. As I was about to move off, I felt a hard knock at the rear of my vehicle. I then braked and exited my vehicle. I discovered that another vehicle driven by a male Chinese in his 40's to 50's clad in White Polo-T and jeans had knocked into the rear of my vehicle. From my visual view, my vehicle suffered damages (i.e. scratches) to the rear bumper. We did not exchange particulars as we noted down each other's vehicle registration number. I then sent my vehicle for servicing at Comfort Delgro Located at Sin Ming

On the same day, at about 1700hrs, I went to Parkway East Hospital as I was still feeling pain at the lower back of my neck due to the accident earlier along Bishan Street 21. I was then discharged with medication. On the same day, between 2100hrs to 2200hrs, I felt severe pain at my lower back of my neck and went back to Parkway East Hospital. I was then warded till 10 December 2018, where I was later discharged with 10 days of medical leave. My discharge summary from A&E indicated that "MRI
