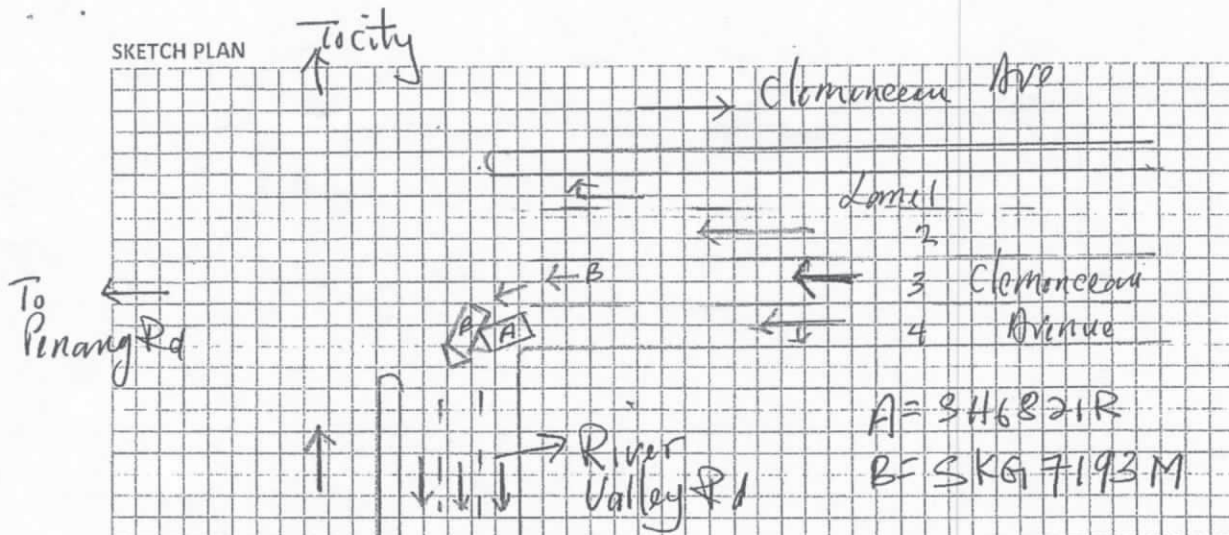

SH 6821 R - ACCIDENT STATEMENT

Today(9/02/2018) a male passenger boarded my taxi in city area for a trip to Penang Road.

I travelled on Clemenceau Road and I stopped my taxi at River Valley Road when it was red light signal at the said junction.

As seen in the video footage, when the cars in front my taxi moved forward following the emergence of green light and as I followed suit to travel straight across the junction, my taxi was suddenly hit into by car B(SKG 7193M) amid turning into River Valley Road from lane 3 on the 4-lane road of Clemenceau Avenue side.

It was clear road sign on my lane which showed that I could either move straight or turn left at the junction while the lane where car B came from was a mandatory 'travel straight' lane.

I took photos at the scene.

The impact caused damage to the right front of my taxi while the left rear to car B was dented.

No report of injury at the time of accident.
