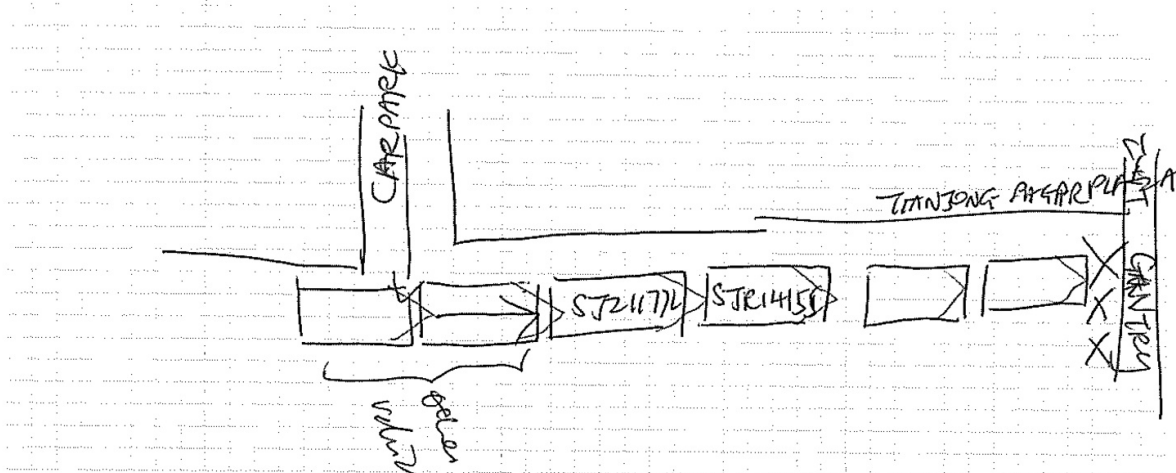

SKETCH PLAN




DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

SKETCH PLAN




