SUDDENLY, I FELT AN IMPACT FROM BEHIND. WHEN I CAME OUT TO INSPECT MY CAR, I REALISED THAT VEHICLE B (GBB5468S) DID NOT STOP IN TIME AND COLLIDED ONTO REAR PORTION OF MY CR. DUE TO THE HUGE IMPACT, ME AND MY PASSENGER ARE NOT FEELING WELL AND WENT TO SEE DOCTOR AFTER ACCIDENT. DOCTOR GIVEN 2 DAYS MC. IF WE STILL FEEL UNCOMFORTABLE AFTER THIS, WE WILL CONTINUE OUR MEDICAL TREATMENT. I HERE TO LODGE THIS REPORT TO CLAIM AGAINST VEHICLE B'S INSURANCE FOR MY ACCIDENT DAMAGES AND INJURIES MEDICAL.

**SKETCH PLAN**




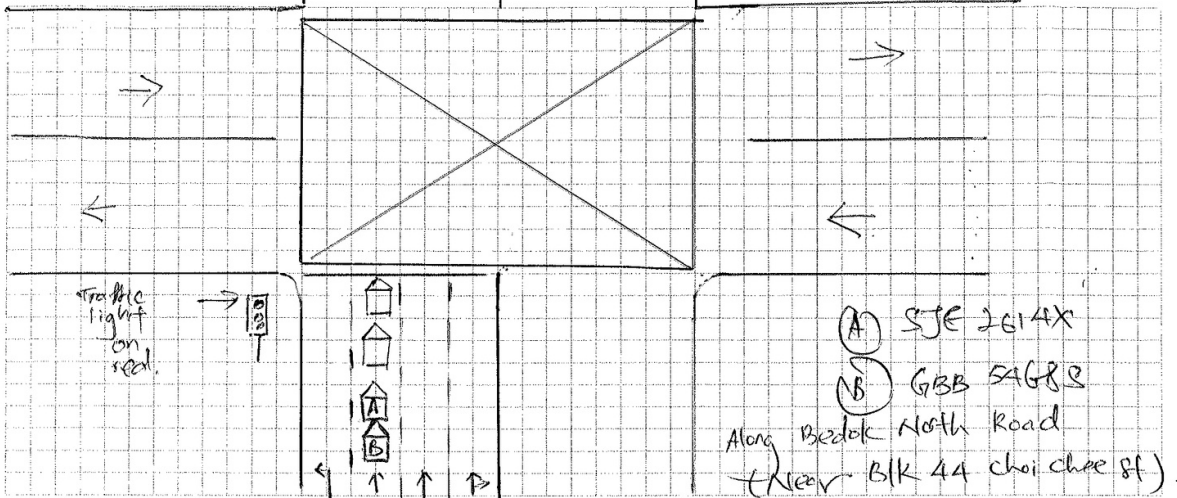

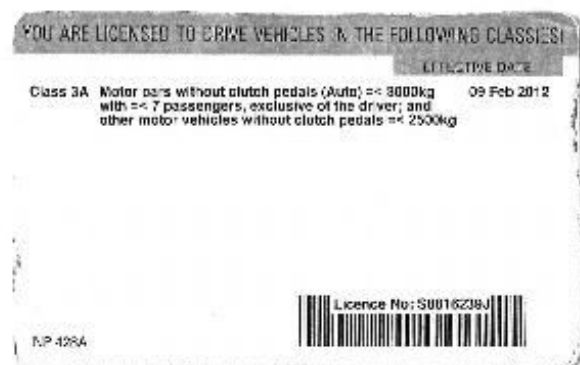

#### 4. RENTAL TERMS

The Driver hereby agrees to pay the owner at the rate of \$320 per week for the rental period from:

Ending Date: 16 APR 2018 (MON)

The first payment is due on the 13<sup>th</sup> Nov and subsequent payments must be paid on the Mon of each week. A fee of \$40 will be charged for late payment of rental.

The Vehicle is handed over to the Driver on 6/11/17 2330 (Date/Time) on with 80% tank of fuel.

The Driver must return the Vehicle the Owner's address by 11pm on the Ending Date with the same amount of fuel.

#### 5. REPAIR AND MAINTAINENCE

The Owner shall bear all costs require to ensure that the Vehicle is insured and roadworthy and complies with the requirements of the Road Traffic Act or any statute, rules or regulations applicable in Singapore. The driver will bring the vehicle to the designated workshop when repair or maintainence is required. The workshop will determine the repairs needed to keep the vehicle roadworthy, and the repairs will be paid by the Owner.

The Driver agrees that repair and maintainence is part of the normal upkeep of a vehicle and no compensation or replacement vehicle will be provided during this period unless repair exceeds 24 hrs.

Flat battery due to negligence, punctured tyres, empty petrol tank, loss of vehicle key or locked key inside the vehicle are not considered maintainence and repair.

#### 6. EXCLUSIONS

The rented Vehicle shall not be used to push, propel or tow another vehicle, trailer or any other thing without the written permission of the Owner. The rented Vehicle shall not be used for any illegal purpose or in a negligent manner. The Vehicle shall only be operated only by the Driver stated in this contract unless with the written permission of the Owner. The driver must have a valid license during the period of usage.

## RENTAL AGREEMENT

### 7. DEPOSIT

The Driver agrees to make a deposit of \$500 with the Owner, said deposit to be used, in the event of loss or damage to the vehicle or equipment during the term of this Car Rental Agreement, to defray fully or partially the cost of necessary repairs or replacement. In the absence of damage or loss, the deposit shall be returned to the Driver within one week of the Ending Date of rental.

### 8. DRIVER RESPONSIBILITY

The Driver is responsible for all damage and loss, both to the vehicle or to other parties, due to accident, theft, or any other reasons, included during the period of rental. The Driver is also responsible for all traffic offenses and fines incurred during the rental period.

An insurance with excess of \$1500 is included to defray the cost incurred by the driver to third party claims. This insurance is subject to the terms and conditions of the insurer.

An insurance with excess of \$2500 is provided by the Owner to defray the cost incurred by the driver for damage to the vehicle. If the vehicle is used in an unauthorised manner (6. Exclusions), this insurance does not apply and the Driver is responsible for all damage or losses incurred.

### 9. PENALTY FOR EARLY TERMINATION

The discounted rental rate provided in this contract is possible only because of the length of contract the Driver has agreed to take. Thus, an early termination of contract is viewed as a breach of trust to the Owner.

a. Early termination without notice: The Driver has to pay the Owner a penalty of \$800 + \$80 per week remaining in the rental agreement.

b. Early termination with notice: If the Driver provides 2 weeks notice prior to early termination, the driver has to pay the Owner a penalty of \$500 + \$40 per week remaining in the rental agreement.

The penalty must be paid in full on the day of termination. Any cost incurred (eg, legal costs) for the recovery of the penalty will be borne by the Driver in addition to the penalty.

We agree to the terms stated in Clauses 1-9 of the Car Rental Agreement.


