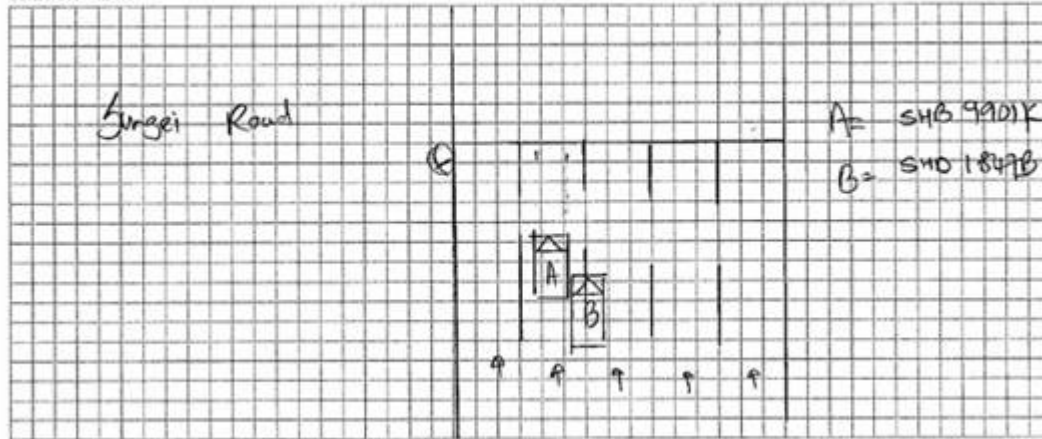

Brief Details.

On 09/02/2018 at about 2220hrs, I was driving my taxi bearing the plate number SHB9901K along Sungei Rd towards ECP. My taxi was stationary at the traffic junction of Sungei Rd and Jln Besar. Suddenly a silver taxi bearing the plate number SHD1847B collided onto the rear end of my taxi and the taxi continued to move to my right side. Which caused the right rear end of my bumper to be damaged as well. There was a vehicle bearing the plate number SJJ7302L which was about 3 to 4 car length behind me. The driver told me that the in car camera footage in his vehicle had capture the accident and he was willing to be my witness if needed. However, after taking photos of the accident I felt pain on my chest and body. Hence, I sat in my taxi while I was waiting for the ambulance. Later on, I was conveyed to Tan Tock Seng hospital and I was given 4 days of MC. I was also contacted by a traffic police and the officer told me to lodge a police report and to report to Traffic Police HQ on Monday.
