

On 13/02/2018 at about 0850hrs, I was riding my motorcycle bearing registration plate no. FU7092G along Kim Keat Road towards Balestier Road on the second lane of the three lane road. At before the junction of Balestier Road, at the first yellow box, there was a SBS bus which had stopped before the yellow box on my left. While I was still moving forward to form up, a silver coloured van bearing registration plate no. GT9875U came out from the small alley way on my left, just beside Botak Jones, and passed the front of the bus. The van then proceeded to hit onto my motorcycle from the left, resulting in me being thrown off from my motorcycle.

The van driver then got down and made a check on me and his vehicle. I got up by myself and we exchanged particulars before the van driver moved off, and I pushed my motorcycle to call for a tow crew as I was unable to ride due to the damages to my motorcycle and my injuries. After my motorcycle got towed, my father drove me to TTSH to seek treatment. At around 1017hrs, I was admitted to TTSH for a day for observation and was discharged on 14/02/2018 at about 0903hrs. I was given 3 days of hospitalization leave and some painkillers. The doctor diagnosed that I had some abrasion and bruising




