

ON 13/02/2018 @ 0110 HRS, I WAS DRIVING MY TAXI (SHD 1064 T / SILVERCAB) ALONG SERANGOON CENTRAL - (NEAR BLK 262), WITH 1 MALE PASSENGER ONBOARD (CHINESE MALE), IN THE LEFT LANE.


I SLOWED DOWN TO A STOP TO ALLOW THE PASSENGER ONBOARD MY TAXI TO ALIGHT (HAZARD LIGHTS WAS ON AT THE SAID TIME), AFTER THE PASSENGER ALIGHTED. I THEN REALIZED THAT VEHICLE B (PC 5451 T / TOYOTA VAN - WHITE) WAS BEHIND ME. MY TAXI REMAINED STATIONARY TO ALLOW VEHICLE B TO OVERTAKE ME BEFORE MOVING OFF.


