AHEAD.

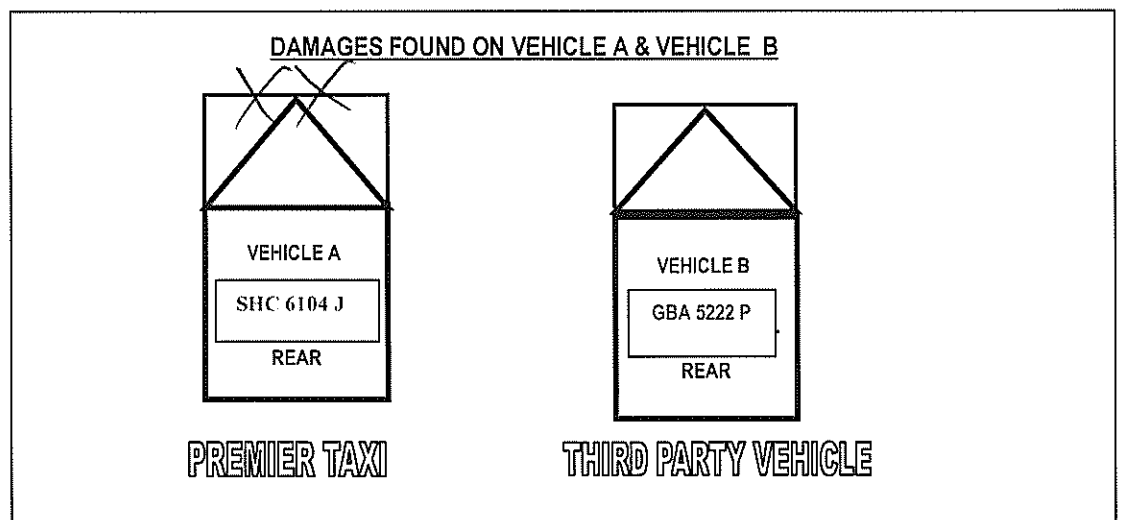
WHILE STATIONARY, SUDDENLY VEHICLE B BEGAN TO

REAR OF VEHICLE B COLLIDED ONTO THE FRONT PORTION OF MY TAXI.



DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE FRONT PORTION
