Here is an accurate recount of the accident: Due to a very large pillar on my right acting as a blind spot, I edged out of the lot slowly and cautiously in order to gain vision of oncoming cars from the right. I saw Mr Goh, the 3rd party witness, who was in the yellow car at the car park gantry but stopped moving to allow me to exit from my lot. I edged forward slightly more to gain vision of cars coming from the right but immediately slammed the brakes when I saw the oncoming vehicle (**SKH 3135C**) approaching my car direction at a high speed. However, she could not stop in time as she was speeding in the car park and grazed the front of my stationary car as a result. I am definitely certain I took careful precautions as I edged out slowly to gain a view of vehicles coming from the right due to the large pillar acting as a large blind spot for me. Please kindly refer to the footage attached, you will see that the driver of (**SKH3135C**) was travelling over the speed limit allowed in any car park where cars are in close proximity with one another. The 3rd party witness can also verify that the driver was speeding in the car park.

Thank you for taking the time off to review my case. I sincerely believe that I was not at fault and I hope that the points stated above can better help you see things from my point of view.
