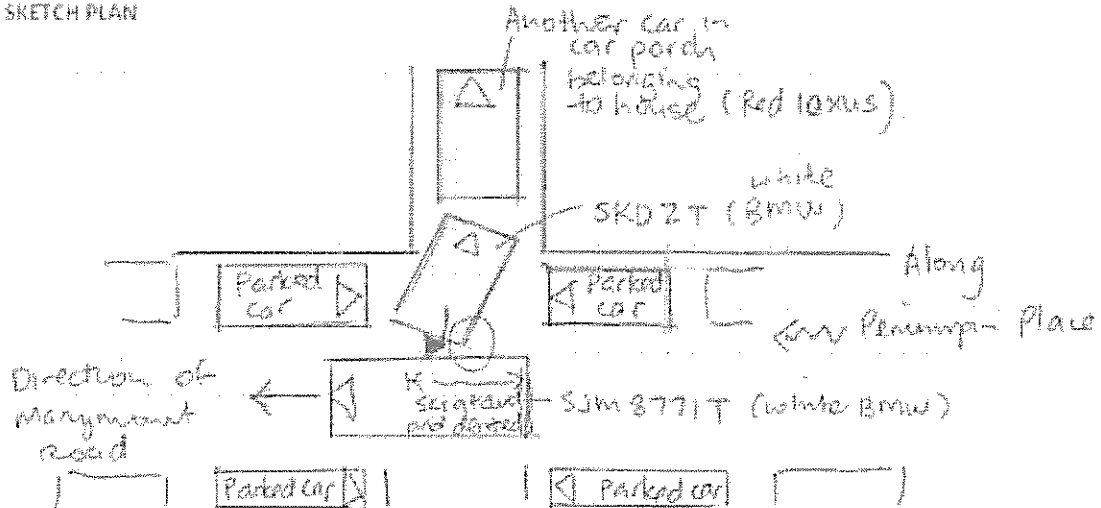

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 11 Feb 2018 at about 6:45 pm, I was driving motor car no SJM 877T along estate road Peninpin Place in the direction of Marymount Road when suddenly, motor car SKD 2T parked out from house no. 164 Peninpin Place and collided with and scratched the right side of my motor car.
My motor car was scratched and slightly dented from the right front door below the door handle all the way to the rear bumper. The corner left of the rear bumper of motor car no SKD 2T was scratched, and the driver of motor car no SKD 2T was Low Yen Fong (S7640265 E).
As there are parked cars along both sides of estate, I was driving slowly and even slowed down for a domestic helper who was walking along the road, before the collision happened.
