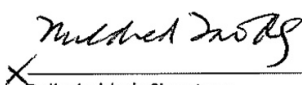
SKETCH PLAN

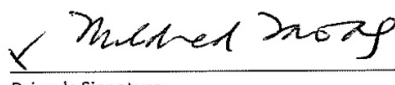

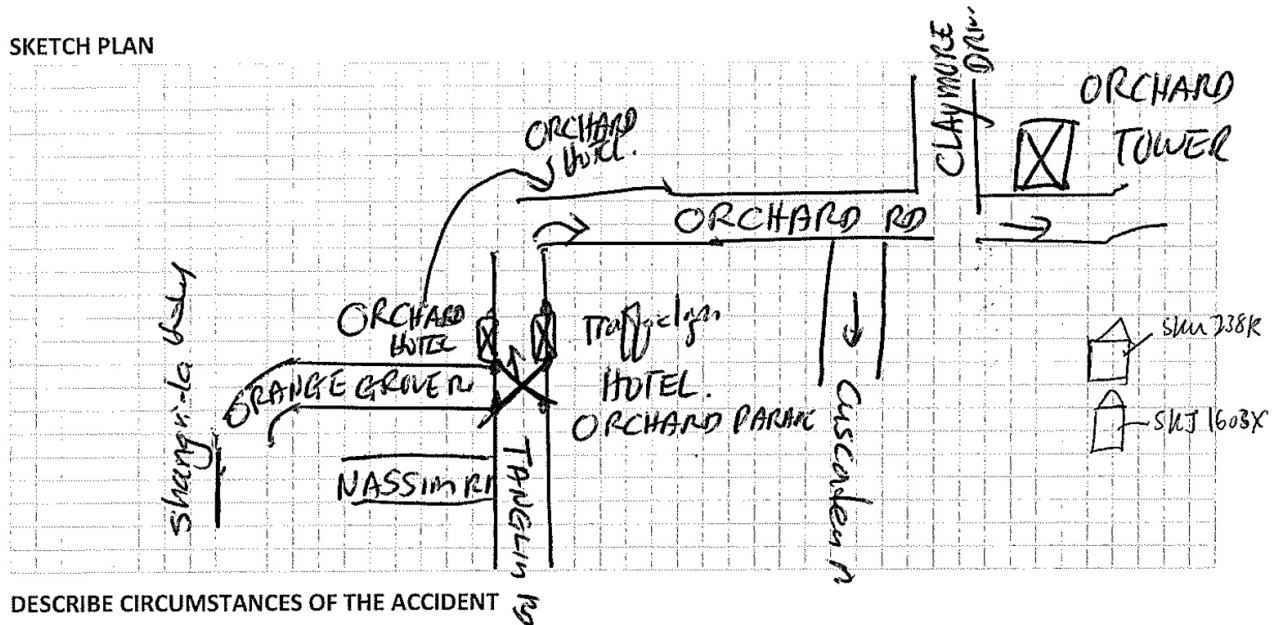

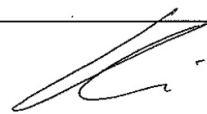
