
The weather for the day was clear, visibility was good & traffic was light. This is a google Street view of the slip road which I entered where the accident occurred.

Video footage taken at the point of contact is attached. The slip road only allows one vehicle at a time and there should be no overtaking. From the diagram SKH1218K which is coming from behind should keep a proper lookout for the front as I need to keep my eyes to the front and to my right for oncoming vehicles as I exit the slip road.
