
SKETCH PLAN





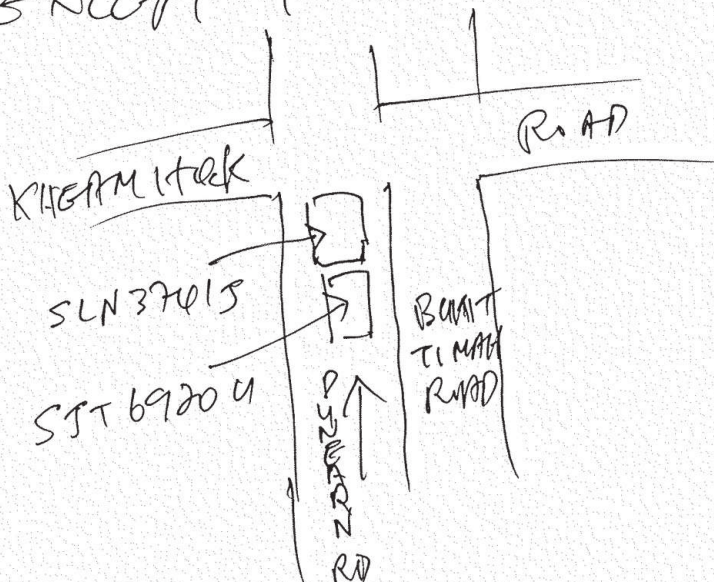
