Hi Mr. Bryan,

I submitted the request on 06/02/2018, however, I just received an email from my side that the procurement for the inspection had just been approved.

2. This is a case of a road traffic accident involving a pedestrian and a Malaysian motorcycle which took place on 31/01/2018 at about 723am. Rider informed that he was travelling on lane 2 of 3 and was approaching a signalised pedestrian crossing. When traffic light changed from green to amber, rider applied brake, but claimed that he was unable to stop the motorcycle and his brakes were ineffective. He then collided into the pedestrian who was crossing at the said signalised pedestrian crossing on 'green man'.
3. I would appreciate it if the inspection could be done soon as the rider said that he requires the motorcycle for his daily commuting in and out of Singapore.
