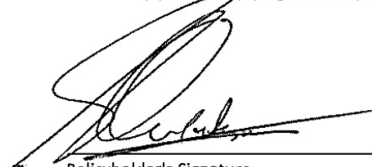

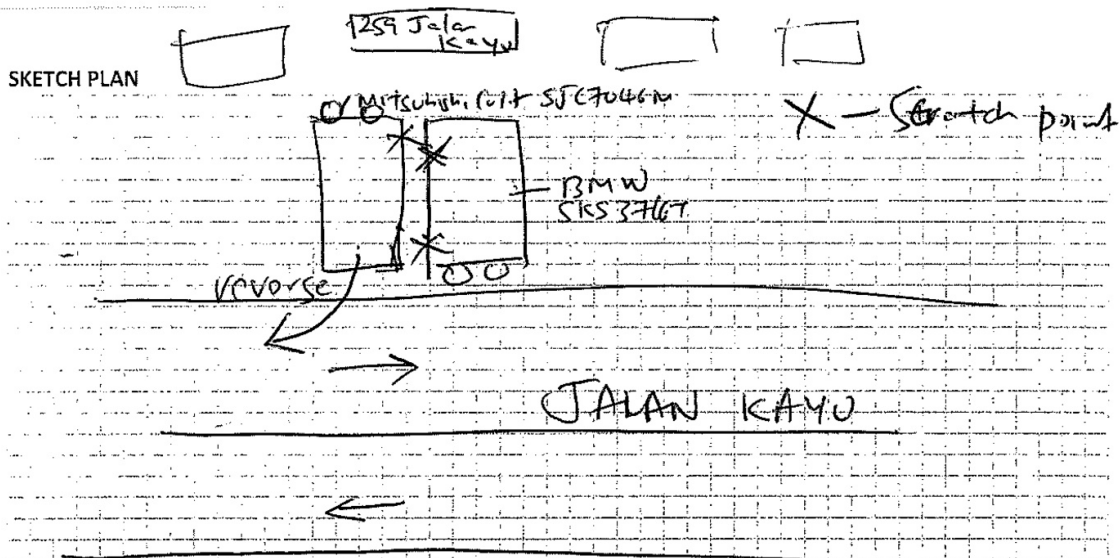

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

My Car SKS3716T was parked in front of 259 Jala Kayu between 2000-2100. I did not witness the accident. The other car which collided into my car, left a message on my windshield. I contacted him and he gave me the circumstances of the accident. At around 21:00, the Mitsubishi Colt SJC7046M, attempted to reverse onto Jala Kayu from the parked position. As he reversed, the left front of his car (left of his bumper), hit the right front driver side of my car. This collision caused lines of paint from my car to be removed resulting in linear scratches. There was minimal damage to his car on the left of his bumper. I also discovered today on checking that the rear door, and panel parallel to the front panel has also been scraped.
