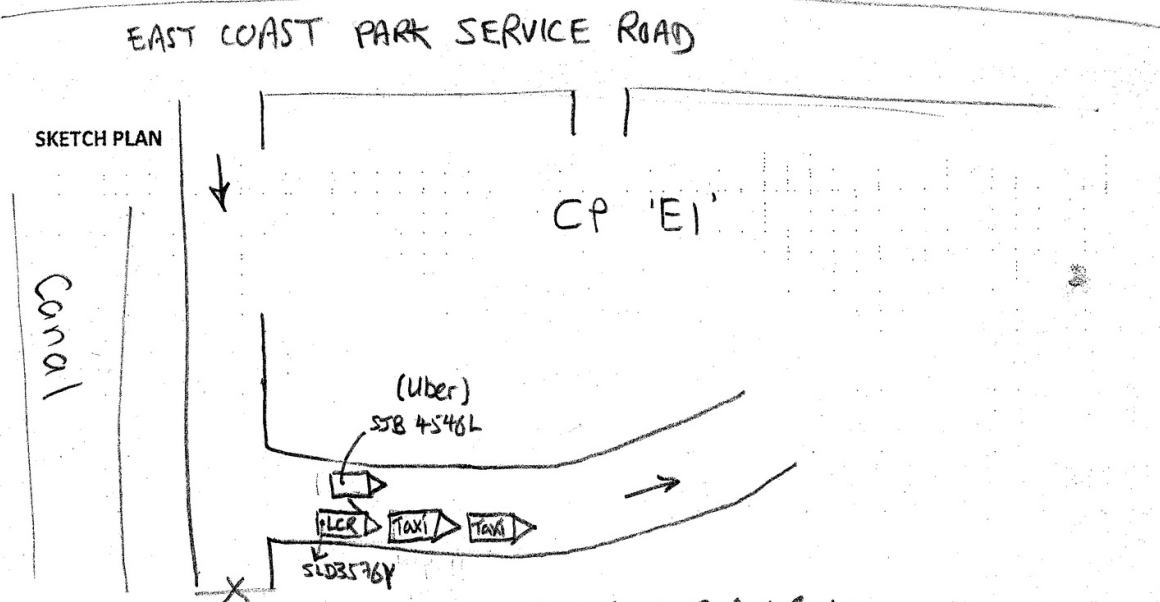

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

East Coast Seaford Centre

The accident took place on 13/2/18, 7.35pm as shown in above diagram. I have stopped my vehicle behind the two taxi along a single directional way road at East coast Seaford centre carpark CP 'E1'. I saw it was safe to allow my front rider alight hence allow him to open the front door. As my front rider open the front car door suddenly another uber vehicle (SJB 4546L) dashed over my vehicle and hit my vehicle front door without slowing down to let his rider alight. This uber driver should have stop behind my vehicle because it is a single directional road. The damages of my vehicle left front door appeared at the bottom of the door caused the other uber vehicle (SJB 4546L) rear wheel fender ^{arch} to rip off.
