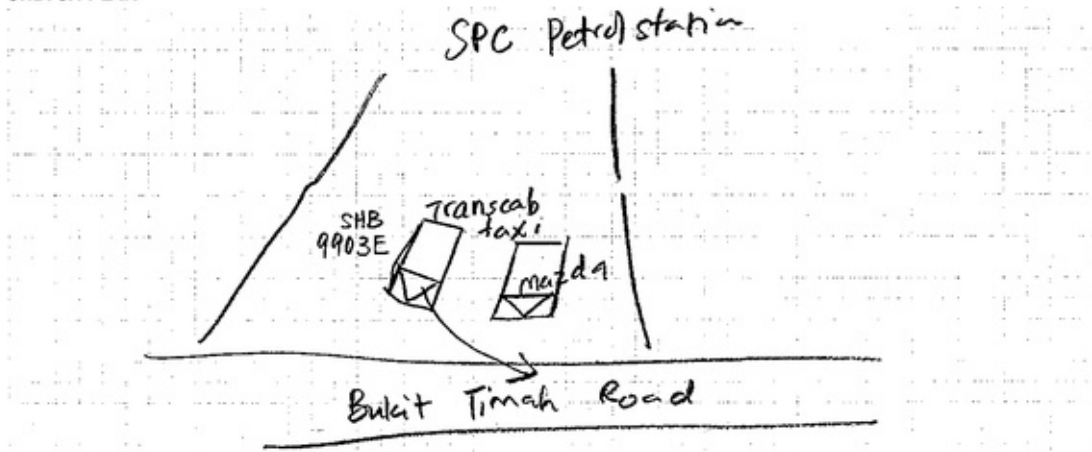

SKETCH PLAN




DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

At the exit of the petrol station, both cars were waiting for the traffic to clear before we could turn left to enter the main road. (Bt Timah Road after Balmoral Road). I was at the left and the taxi was on my right. The taxi moved first but he turned too sharply left and side swiped my right mudguard area. I have not moved yet. It appears that he was looking right to see the traffic and misjudged the clearance on his left when he moved out.
