CONTINUATION OF REPORT

Brief Details.

On 16th February 2018 at about 9.20-9.30pm, I was travelling with one passenger in my taxi (SHB7877K), along Cavenagh Rd, towards Holiday Inn.

It was a straight road and there was no traffic, so I proceeded when suddenly, a taxi (SHC6722A) from the opposite direction, made an illegal U-turn, crossing the continuous white line between our lanes. His taxi then hit the right side of my taxi.

The damages to my taxi are: Right side front door and back door dented and scratched.

There was no in-car camera in my taxi during the accident.

I went to Mount Alvernia Hospital to consult a doctor and obtained a 5-day MC. My injuries are: Pain in the back, shoulder and neck.

I'did not manage to get the other driver's particulars.
