Brief Details.

On 14th February 2018, at about 0750hrs, I was driving V1) MID33 along Glement Avenue 2, lane 1, traveling towards Clementi Road, V2) SJ\$3355K was then traveling at the opposite direction. The traffic light was then in my favour. My vehicle was V1 was the approaching the junction of Clementi Avenue 2 and Clementi Avenue 5, V2 was then stationary at the opposite lane, waiting to make a right turn. Out of a sudden, V2 made an attempt to make a right furn towards my direction. During the attempt, V2 accelerated while V1 was near the junction. Lapplied emergency brake on V1 however the distance was too near to prevent contact, thus causing a collision between V1 and V2, V1 sustained damaged such as several scratches on the front left bumper and grill damaged. No one was injured at scene. There was no in-built camera in my vehicle, V1. I had exchanged particulars with V2's driver. V1 is yet to send for damage assessment.
