

Brief Details.

On 19/02/2018 at about 1000hrs, I was driving my car bearing registration plate number SJK6905Z along Queen Street. While in front of Bugis+, vehicles in front of me came to a stop, as such I stopped my vehicle as well. When my vehicle is stationary waiting for the vehicles in front to move off, suddenly there was a collision from the rear right of my vehicle. There was a car bearing registration plate number SDR818R who had collided to the rear right of my vehicle, however the vehicle did not stop and drove off.

I then gave chase and managed to stop the car at Victoria Street in front of Bugis Junction tower. The driver together with a female passenger then stepped out of the vehicle. The driver then refuse to show me his driving license and only written his name as "KC Tan, +65 96313113, 7409237C". Subsequently I gave a call to the given number and a female lady picks up and claimed to be the mother of KC Tan. They wanted a private settlement, however they wanted me to sign of a form which only consist of my name. I told them to use the private settlement form which was downloaded from insurance website, however they refused.

I find that it is very fishy that the driver do not exchange particular with me and they did not stop their vehicle when they had collided with my car. I have in-car CCTV recordings.
