Hi Mr Ng,

We refer to the above matter.

Third party reported that he was driving along the 2nd lane of Hill Street towards Victoria Street. Our insured vehicle was on the 3rd lane. Both vehicles stopped at the traffic junction. When the traffic light turned green, both vehicles moved off. Our insured who was on the 3rd lane did not keep to her lane and encroached into third party lane. Third party driver immediately started to horn but our driver did not realise and grazed across third party taxi and continued to move. Third party driver then high beam and horned at our driver. Then our driver came to stop.

Our insured driver reported that she was driving on the 3rd lane of Hill Street towards Victoria Street. As the traffic light turned red, she stopped at the junction. After the traffic light turned green and she proceeded to drive. Third party driver who was driving behind her on 2nd lane suddenly high beam her. She proceeded to stop at the road side and third party driver told her that her car and hit onto third party taxi. Our insured driver refused to private settle as she was not at fault.

Both parties has no video footage/ concrete evidences to support either version.

In view of conflicting version, we propose to settle the matter at 50/50. The summary of claim is as follows: -
