OFFENCES AND PENALTIES APPLICABLE**

We refer to your application for a Private Hire Car Driver's Vocational Licence (PDVL) and the Approval to Drive / In-Principle Approval letter issued to you, informing that you are eligible to continue providing chauffeured services up till 30 June 2018 prior to obtaining your PDVL.

As communicated to you in that letter, you will be subject to rules and legislation applicable to the providers of chauffeured services, including without limitation, the Road Traffic Act, the Road Traffic (Public Service Vehicles) Rules, the Road Traffic (Public Service Vehicles) (Vocational Licences and Conduct of Drivers, Conductors, Trishaw Riders and Passengers) Rules, and applicable legislation on vocational licence demerit points. If you do not comply with these rules, your Approval to Drive / In-Principle Approval may also be revoked and your existing PDVL application rejected.

Please refer to the attached document for the list of PDVL offences and penalties which are applicable to private hire car drivers providing chauffeured services. Please note that this is not meant to be exhaustive and you are subject to all applicable rules under the Road Traffic Act and its subsidiary legislation.
