Brief Details.

On the 06/01/2018 at about 10.40AM, I was travelling in my vehicle SKJ2688U, along Eng Hoon Street, finding for a car park lot. I intended to park my vehicle at the said location as I wanted to get a haircut.

As I was travelling along the location, I made a right turn to a small carpark along Eng Hoon Street to find for a carpark lot. As there are no carpark lots at the location, I exited the car park. I wanted to exit the said car park, however, there was another vehicle who has stopped before the exit of the said carpark. Due to this, I could not make a check for oncoming vehicles coming from the right.

I drove my vehicle forward by a bit until I could see the oncoming traffic from the right. As I inch forward, I then saw a lorry (GBD8420Z) coming towards my direction. I stopped my vehicle to allow the lorry to move first.

However, the lorry did not avoid my car and collided onto the right side of my vehicle. I exited my vehicle, and went to the said lorry to ask the driver to exchange our particulars. The driver was un-cooperative and refuse to give me his particulars.

The said lorry driver was aggressive towards me and even at one time raised both his fists, indicating as if he wanted to fight with me. I was insistent with his particulars. However, he still refuse to give me his particulars. I offered to give him my particulars, however, he refused to write it down.

The employer of the driver came down to the incident and just informed me to take pictures of the accident and file the incident to our respective insurance company. The driver together with the employer drove off from the location.

I wish to state that my vehicle's front right bumper and headlight was damaged. No one was injured. My barber by the name of Mr Carrick Loh (Contact No: 62225590) witnessed the incident and can be
