As per your request ,please refer to the 7 photographs of the taxi vehicle that our driver Mr Hadi Lim took with his I-phone from the drivers seat of the Volvo, before he stepped out to meet the taxi driver who according to a letter sent by his lawyer is named Mr Thong Kuang Shin who is reported to be claiming both body injury and car damage. I hope the pictures taken of the taxi SHD 6601K is helpful to you.

Attention Ms Sharon Lee of Charn's Customcraft

Hi Sharon

We were shocked when Ms Joy Irene of LKK Auto Consultants Pte Ltd called our driver Mr Hadi Lim on his mobile late in the afternoon of yesterday (around 6:30pm 28th March asking questions about the accident). It was in the morning today (29th March) after I called and spoke to Ms Joy Irene that we discovered AXA Insurance has appointed them due to body damage claims by the taxi driver Mr Thong Kuang Shin.

If you refer to the detailed Police Report dated 26th March 2018 filed and signed by Mr Hadi Lim with the help of the Recording Officer in attendance , the car driven by Mr Hadi Lim only made a slight nudge to the vehicle/taxi in front. There are witnesses to this accident as the taxi was carrying two passengers when the accident happened and our domestic helper Ms Gumaru Jane Adarme (28 years old) and one of our grandsons Master Matti Yupangco (8-1/2 yrs old) were in the passenger seat of our car. Mr Hadi Lim's Police Report filed on 26th March 2018 was the result of a letter dated 16th March 2018 from the Singapore Police Force advising us to lodge a Police Report and it is likely a consequence of an earlier action taken by Mr. Thong Kuang Shin.

Based on Mr Hadi Lim's personal experience and account of the accident and eye witnesses in our vehicle driven by Mr Hadi Lim; and in addition independent pictures of our vehicle SLB4423J taken by Ms Sharon Lee/Reina of Charn's Customcraft when he personally drove the same vehicle to the latter's workshop on the following day (27th February 2018) and filed an accident statement at 14:49hours; there's no doubt that the claims filed by the driver of the taxi Mr Thong Kuang Shin is not consistent with the actual accident that happened at 15:45 hours on 26th Feb 2018 as per details of Police Report signed and recorded on 26th March 2018 by Mr Hadi Lim.
