Describe Circumstance of the Accident.

* OPENING DOORS OF VEHICLE *

ON 26/02/2018 @ 1415HRS, I WAS DRIVING MY TAXI (SHC 6056 P) TRAVELLING ALONG GEMMIL LANE – AFTER CLUB STREET WITH A PASSENGER ONBOARD.

WHILE MOVING STRAIGHT AHEAD, SUDDENLY I FELT AN IMPACT FROM MY LEFT.

WHEN INSPECTED, I DISCOVERED THAT A PASSENGER FROM VEHICLE B (SHA 4537 S – COMFORT TAXI) – FAILED TO KEEP FOR PROPER LOOK OUT HAD OPENED THE REAR RIGHT DOOR ABRUPTLY.

AS SUCH, THE REAR RIGHT DOOR COLLIDED ONTO THE LEFT PORTION OF MY TAXI.

DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE LEFT PORTION AND VEHICLE B HAD DAMAGES ON THE REAR RIGHT PORTION.

MY PASSENGER - MR JEFF WHO WAS IN THE REAR SEAT WILLING TO BE MY EYE WITNESS.

VEHICLE B HAD 2 PASSENGERS ALIGHTING.
