We refer to the above matter.

It was reported that the Insured vehicle was making a turn at the junction when collided to TP vehicle that was going straight on the opposite lane.

We called Insured Driver Mr Sallehudin Bin Said several times but to no avail. As such, we leave a message to the colleague to call back and also we sent out letter to the Insured on 10/05/2018 and agreed to settle the matter. No feedback from Insured/Driver till date.

In view of the above, we are of the view that liability is not to our Insured's favour and the damages sustained to TP vehicle were consistent to the nature of the accident.
