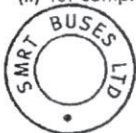

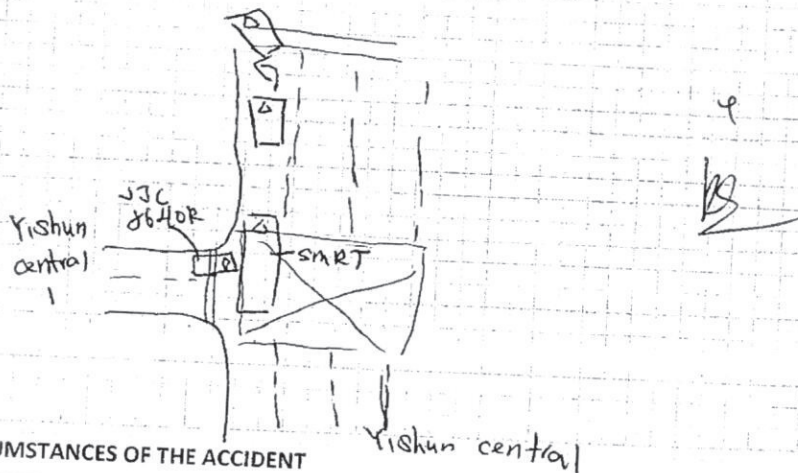

SKETCH PLAN

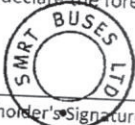
