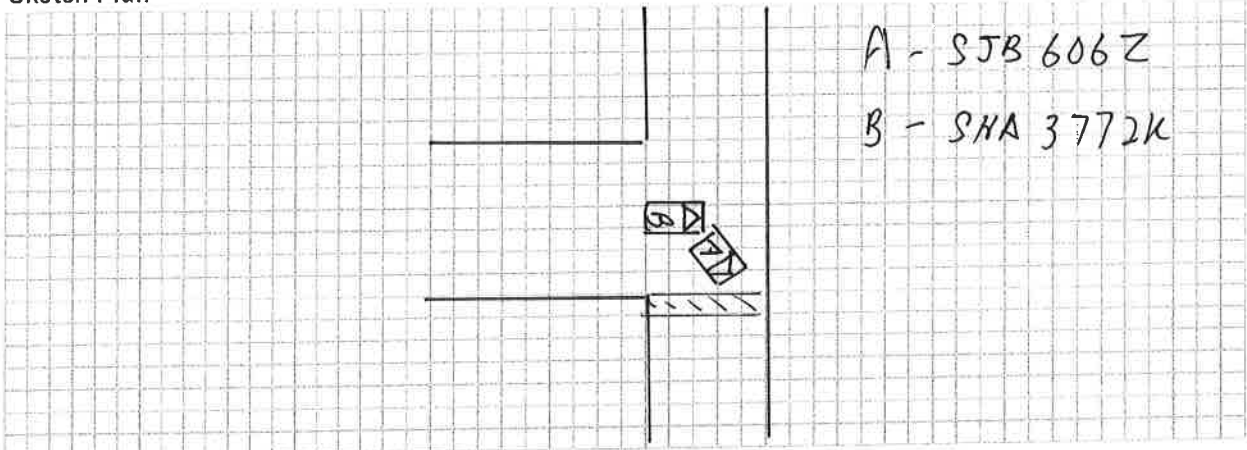

Brief Details.

The driver of SHA3772K informed me that he saw my vehicle came to a stop. However, he could not brake in time as such he tried to swerve to the left in order to avoid any collision. Thus, it caused the right side of his front vehicle hit against to the left side of my rear vehicle.

There are scratches on the right front of his vehicle SHA3772K. My rear bumper was damaged and cracked.

I would like to inform that there is in-built car camera in my vehicle however it only capture the front view.

There is nobody injured at that point of time and there is no police attend to us. I am lodging this report for my own recording purpose.


