Refer to Police report no:T/20180202/2146 lodged at Kebun Baru NPP. On 31/12/2017 at about 2100 hours I was driving back along north south highway in Malaysia back to Singapore. My wife and daughter were in the car at the point of time with me. As we were reaching towards Malaysia checkpoint it was very congested and the traffic condition was very bad. I was in the middle lane and not sure how many lanes there in total. Suddenly one car (SGY3669L) came from the side and hit my right side mirror. He then moved in front of me. I did not try to get hold of him then as the traffic was bad and I did not want to hold up the traffic more. I wanted to talk to the driver at the immigration itself. As i reached Malaysia checkpoint, my wife got out of the car to approach the car which hit us. The driver of the vehicle did not get out despite my wife asking him to. I then decided to approach him later. As I reached Singapore checkpoint and knowing that the driver had to get out of customs check I approached him and demanded him to be responsible for his actions and hoping to get a exchange of particulars. He did not heed my words and was hostile in his replies and left soon after. 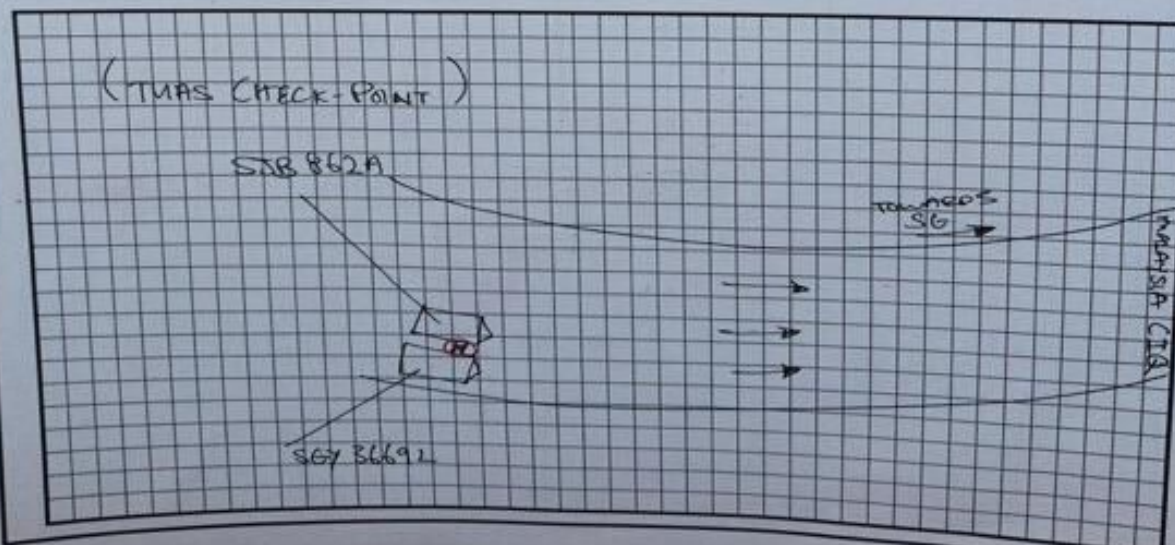
