**Brief Details.**

On the 10/02/2018 at about 0645hrs I was riding my vehicle (FBG9374B) from Marsiling towards Jalan Angklong for work.

On that current time I was riding along Upper Thomson Road on the left most lane on a three lane road. As I was riding I realized that 01 vehicle (XB9539J) tried to overtake me from the right. Suddenly the said vehicle inched closer to me and my handle hit onto his left side of the vehicle and caused me to skid and fall from my vehicle. A few passerby helped me and called for the ambulance. I then was conveyed to the hospital and warded for 6 days. I suffered fractured left palm, minor operation on my left shin due to the abrasion and minor abrasion and scratches on me. I was then given 35 days of MC.
