SKETCH PLAN



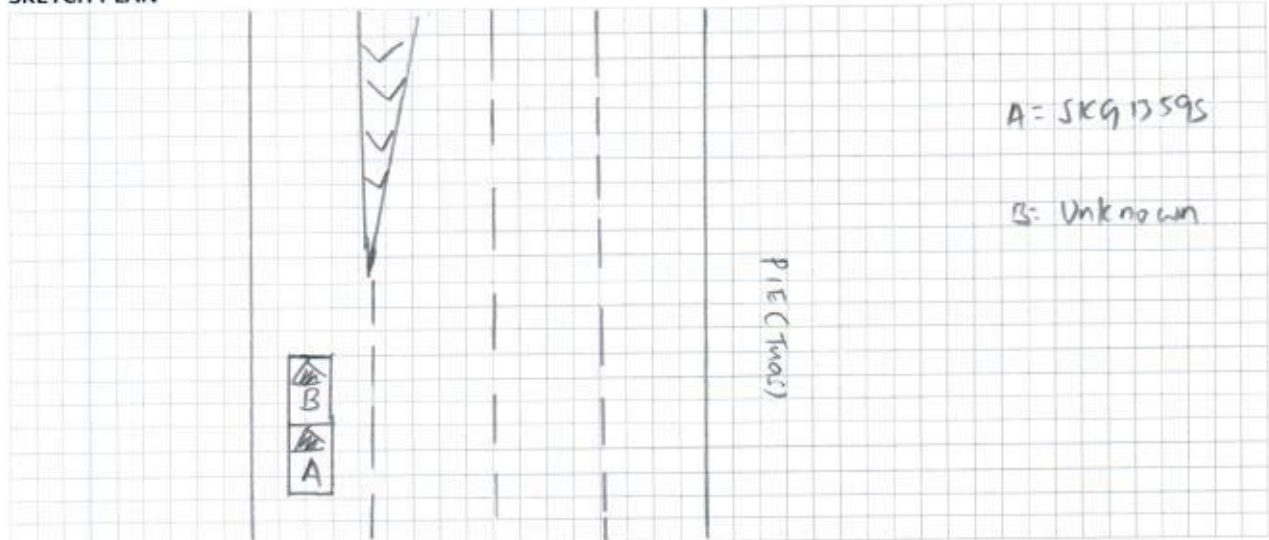
