ACCIDENT INVOLVING VEHICLES XD 4420P (OI) AND SJZ 1177L (TP) ON 03/03/2018

We refer to the above matter.

This is a conflicting version. It was reported by both drivers that the other vehicle had encroached into their lane that resulted in the accident.

We had spoken to the Insured PIC Mr Ng and he was informed of the TP claim and liability issues on 21/05/2018 and agreed to settle the matter. A letter was sent out to the Insured to inform about the TP claim and liability. No feedback from Insured till date.

Both parties have no further available evidence to support their claim and TP repairer is prepared to accept a 50/50 settlement.

In view of the above, we are of the view that liability should be equally shared by both parties involved.
