* OPENING DOORS OF VEHICLE *

ON 09/03/2018 @ 1005HRS, I WAS DRIVING MY TAXI (SHB 8895 B) TRAVELLING ALONG MARINA BAY SAND @ THE CASINO DRIVEWAY/PICK-UP & DROP-OFF POINT.

WHILE I WAS MOVING AHEAD – ON THE RIGHT SIDE OF THE DRIVEWAY, SUDDENLY I FELT AN IMPACT FROM MY LEFT.


WHEN INSPECTED, I DISCOVERED THAT A PASSENGER FROM VEHICLE B (SHB 6395 R – M/BENZ TAXI) WHICH WAS ON STATIONARY ALONG THE LEFT SIDE OF THE DRIVEWAY – FAILED TO KEEP FOR PROPER LOOK OUT FOR MY TAXI – HAD OPENED THE REAR RIGHT DOOR ABRUPTLY.


AS SUCH, THE REAR RIGHT DOOR OF VEHICLE B COLLIDED ONTO THE LEFT PORTION OF MY TAXI.
