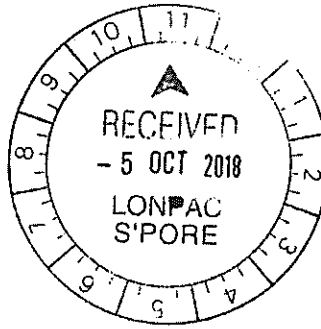

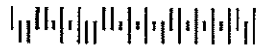

**DE-REGISTRATION STATUS OF VEHICLE SHD3496S**

5. Any unused portion of the road tax will be refunded to you automatically.



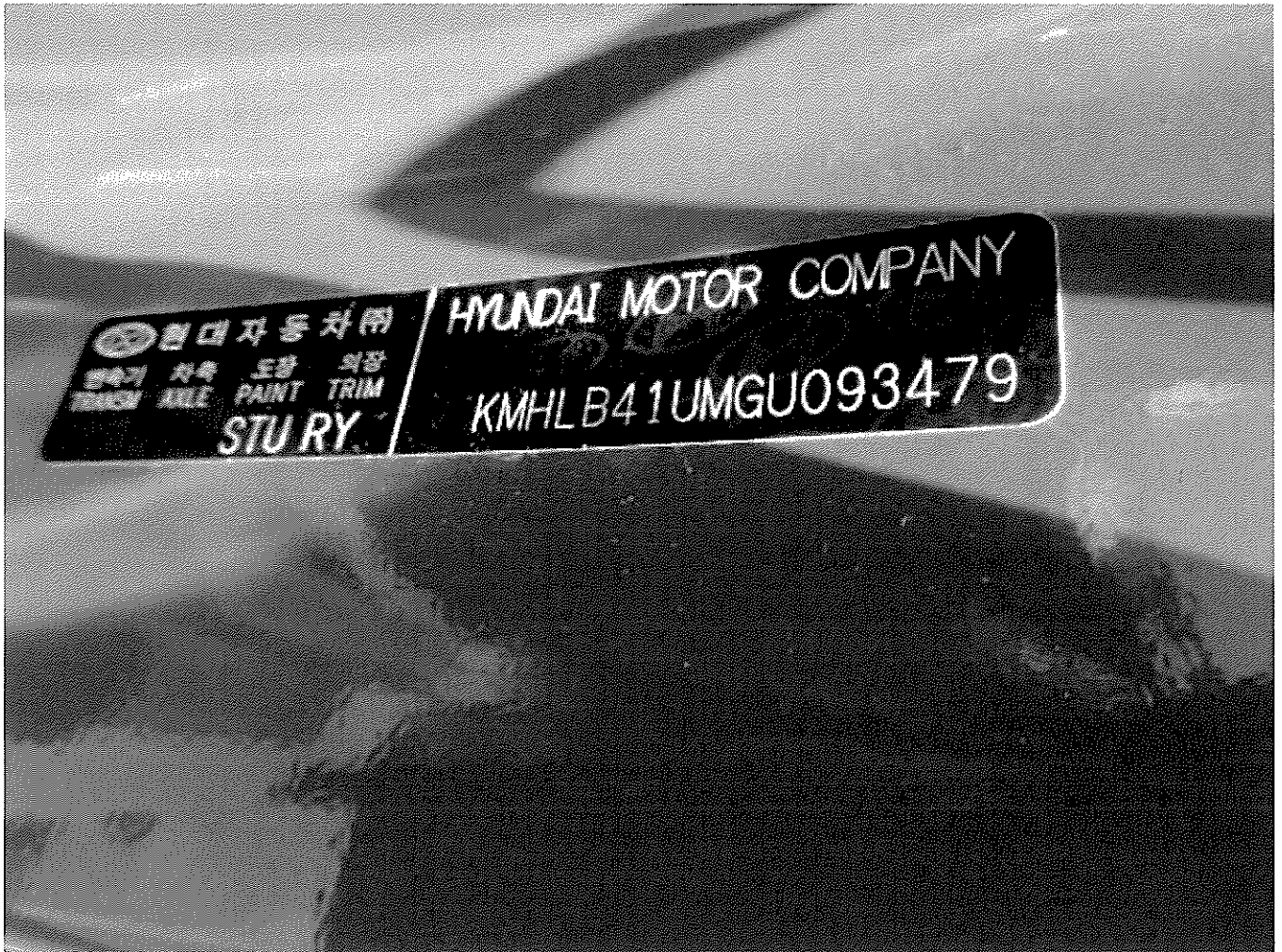
