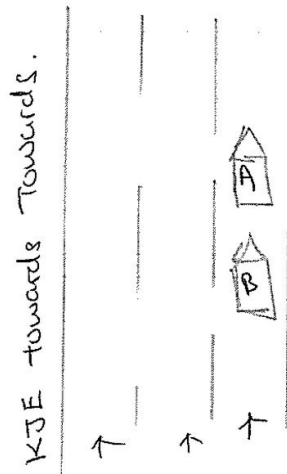

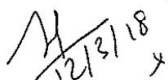

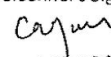
On 12/3/18 @ 9am, I was driving SKZ 3747S along
