Brief Details.

On 10/03/18 at about 1940 hrs, I was travelling along Woodlands Ave 7 heading towards Woodlands Drive 73, on the left most lane. My vehicle is a KIA Cerato Forte, Car Plate: SJS6611D. There was a motorbike from Woodlands 72, going straight towards Woodlands Drive 73. In order to give way, I stopped my vehicle in front of the traffic light, before turning into Woodlands Drive 73, and the traffic light was on red light at that point of time. My vehicle was stationary. Suddenly, I felt a car hit onto my vehicle from the back. The car behind my vehicle is a black Volkswagen car, car plate: SKA3705U. I managed to get the particulars of the driver that hit my vehicle. His name is Yap Choon Poh, S6884106B, Hp: 94515031. My vehicle sustained small cracks, and part of the bumper panel fell off. The sensor at the back of the car was also damaged. I felt pain at my neck and back area, so went to see a doctor at Drs Koo & Neoh Medical Group. I was given MC for 3 days.
