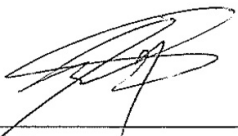
8. Consent under the Personal Data Protection Act (PDPA)

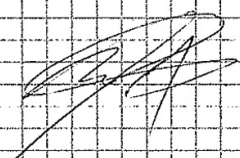

In the midst of collecting the taxi fare from one of them, the one seated on the RH side near of my taxi opened the RH side rear door to alight.

Suddenly a car SLT3448A coming from my right, due to the LH side wing mirror casing grazed against the edge of the opened door.

My taxi sustained some minor scratch only. The car's wing mirror is damaged.
