

**REMINDER TO UPDATE DISPOSAL DOCUMENT FOR VEHICLE NO. SJC5916R**

The above-mentioned vehicle was de-registered on 24 Feb 2018 as the 10-year COE has expired. You should not keep or use the de-registered vehicle but ensure that it is properly disposed of as soon as possible.

2. We would like to advise that under Section 10(1) of the Road Traffic Act, it is an offence for anyone to keep or use a de-registered vehicle. You are therefore required to scrap your vehicle (including the engine and chassis) at an authorised scrapyards or export it permanently out of Singapore. Documentary proof of your vehicle's disposal must be submitted to LTA before 24 Mar 2018 failing which you will be liable for another offence under Section 27(2) of the Road Traffic Act. If convicted, you will be liable to a maximum fine of \$2,000 or imprisonment of up to three months upon the first conviction and to a maximum fine of \$5,000 or imprisonment of up to six months upon subsequent convictions.

3. Please ignore this notice if you have disposed of your vehicle in the required manner and have submitted the documentary proof of export to LTA.

4. The procedure to dispose of/de-register a vehicle is attached for your reference.
