On 13.03.2018 @ approximately 1705 hrs, my car SJX8533G was stationary along Jalan Belangkas. I checked for the oncoming vehicles along MacPherson Road before I make a left turn into MacPherson Road. It was a 3 lanes traffic on MacPherson Road. Two vehicles were stopped before the yellow junction box on lane 2 and lane 3 given way to my car. Thus I proceed to make a left turn into lane 2 as there was one van stopped along lane 3. On my process of positioning my car on lane 2, one car ST303X travelling on lane 1 came in fast speed, subsequently collided into my car frontal right portion.

After the accident, we alighted from our vehicles to check on damages. We exchanged particulars. At the material time, no one was injured in this accident.
