Brief Details.

On the 08/03/2018 at about 0640hrs I was travelling along Queensway towards MDIS on the lane one. As I was approaching the slip road of Margaret Dr, I noticed a Toyota wish on my left hand side wanting to turn out and merge out onto Queensway. I saw the car slow down as he was approaching the junction suddenly he turned out onto Queensway and cut over a span of 4 lanes and cut in front of me. I could not break in time and hit onto the ride side of the vehicle.

A witness who was also a rider called for ambulance for me and I was subsequently conveyed to NUH. I was not aware of what was happening around me as I was in pain.

My friend was on the way to work and spotted my bike. He then inform me that there was traffic police at scene after I was conveyed.

I was given 14days of hospitalization leave from 08/03/2018-21/03/2018. I suffered abrasion on my left fingers, abrasion and swelling on my left knee, swelling on my right waist area.

I do not know what is the damages of my vehicle as it was towed away and I do not know any information of the other driver. My friend had taken a photo of the opposite party's vehicle however the plate number was slightly cut off in the picture leaving it as SJJ7064.
