**De-registration of accident vehicle SKQ1243P**  
**Accident date: 17 December 2017**


We wish to inform you that a LTA technical officer had conducted an inspection on the accident vehicle, SKQ1243P, on 19 December 2017 and has deemed that the vehicle is unfit for further use.

Pursuant to section 27(1)(d)(iii) of the Road Traffic Act, the registration of a vehicle would be cancelled if a vehicle is deemed to have become wholly unfit for use on the roads. Hence, the vehicle, SKQ1243P, was de-registered on 20 December 2017. As the said vehicle was found to be wholly unfit for use, we have backdated its de-registration date to the date of accident (i.e 17 December 2017).

As the registered owner of the vehicle, SKQ1243P, you are required to scrap that vehicle, including its engine and chassis, at an authorized scrap yard or have it exported permanently out of Singapore and furnish documentary proof of the vehicle's disposal to LTA not later than **19 January 2018**. We would like to advise you that under section 10(1) of the Road Traffic Act, it is an offence for anyone to keep or use a de-registered vehicle.

You may also transfer the PARF/COE rebate(s) together or separately to a third party. A fee of \$15.00 is payable for each transfer.

4. Alternatively, you may apply to encash the PARF/COE rebate(s) before the expiry of the rebate(s). For firm and organisation, you can also login using your LTA-issued User ID & Password (up till 30 Sep 2017) or EASY (up till 31 Dec 2017) to register your Refund Bank Account for GIRO refund BEFORE applying online for the encashment (Ownership > PARF/COE Rebate > Apply to encash rebate).
5. Any unused portion of the road tax will be refunded to you automatically.
6. Please note that a separate PIN is required to transfer or split the PARF/COE rebate via the Internet or at our Electronic Service Agents.
